THE BUILDING ZONE ORDINANCE, CHAPTER 85, ARTICLE V OF THE TOWN OF BROOKHAVEN CONCERNING THE FOLLOWING PARCEL:

TIME CREATIONS, INC. FOR A CHANGE OF ZONE AND SPECIAL PERMITS ON PROPERTY LOCATED IN PORT JEFFERSON STATION, NEW YORK

ADOPTED BY THE BROOKHAVEN TOWN BOARD

DECISION NO. MEETING: DECEMBER 8, 2009

RESOLUTION OF ADOPTION - GRANTING THE APPLICATION OF TIME CREATIONS INC. FOR A CHANGE OF ZONE FROM J BUSINESS 2 TO J BUSINESS 5 AND FOR SPECIAL PERMITS FOR A GASOLINE FILLING STATION AND CONVENIENCE STORE ON PROPERTY LOCATED IN PORT JEFFERSON STATION

WHEREAS, on December 8, 2009, a duly advertised public hearing was held to consider the application of Time Creations Inc. for a change of zone from J Business 2 to J Business 5 and for special permits for a gasoline filling station and convenience store on property located on the corner of Dayton Avenue and Route 112, Port Jefferson Station, further identified as SCTM No. 200-137-02-12; and

WHEREAS, approval of this application will allow for redevelopment of the site with a gasoline filling station with a 1,752 sq. ft. convenience store; and

WHEREAS, after due consideration and deliberation;

BE IT RESOLVED that the above-captioned application for a change of zone is hereby conditionally approved subject to the following:

CONDITIONS

1. The applicant must submit proof that the covenants, approved as to form and substance, referenced below have been filed with the Suffolk County Clerk's office.

and be it further

RESOLVED, that the property owner shall impose covenants and restrictions which run with the land and in such form as shall be approved as to substance and form by the Town Attorney's office, recorded in the Suffolk County Clerk's office and thereafter filed with the Town Clerk requiring the following:

COVENANTS AND RESTRICTIONS

1. A minimum 10 foot landscape front yard along Route 112 & Dayton Avenue.
2. Not more than one curb cut per street frontage.
3. A minimum 10 foot landscaped buffer consisting of a double staggered hedgerow of mixed evergreen trees provided along the southerly and westerly property lines.
4. The proposed convenience store shall not be more than 1,752 square feet

and be it further

RESOLVED that the above application for a special permit for a gasoline filling station is hereby conditionally approved subject to obtaining a variance from §85-256(C); and be it further

RESOLVED that the above ap-

plication for a special permit for a convenience store is conditionally approved for 750 sq. ft. subject to obtaining a special permit for a gasoline filling station, and the applicant may make application to the Board of Zoning Appeals to increase same, however, in no event shall the maximum permitted square footage exceed 1,752 sq. ft.

DECLARATION OF COVENANTS AND RESTRICTIONS

TIME CREATIONS, INC., with offices located at 200 Route 112, Port Jefferson, NY 11776, as fee owner (hereinafter "Declarant"), of a certain 0.361 acre parcel of real property located on the southwest corner of Route 112 & Dayton Avenue, in Port Jefferson, in the Town of Brookhaven, Suffolk County, New York, which property is designated as District 0200, Section 137, Block 2, Lot 12 on the Suffolk County Tax Map, and which is more particularly described in Exhibit "A" annexed hereto (the "Premises"), declare as follows:

WHEREAS, the Town Board of the Town of Brookhaven approved said application subject to certain conditions and the imposition of certain covenants and restrictions, as set forth in a Town Board Resolution dated December 8, 2009; and

WHEREAS, Declarant, for the purposes of preserving the value and assuring the orderly development of the Premises, does hereby agree to impose certain covenants and restrictions;

NOW, THEREFORE, Declarant hereby imposes the following covenants and restrictions:

1. A minimum 10' landscape front yard along Route 112 and Dayton Avenue.
2. Not more than one curb cut per street frontage.
3. A minimum 10' landscape buffer consisting of a double staggered hedgerow of mixed evergreen trees provided along the southerly and westerly property lines.
4. The proposed convenience store shall not be more than 1,752 sq. ft.

PLEASE TAKE NOTICE that after due public hearing the Board of Trustees of the Incorporated Village of Port Jefferson, New York, at a meeting held on the 5th day of April, 2010 did approve an amendment to the Code of the Incorporated Village of Port Jefferson as follows:

Section 215-14C of the Code of the Incorporated Village of Port Jefferson is deleted in its entirety.

Section 215-15 of the Code of the Incorporated Village of Port Jefferson is deleted in its entirety and there is substituted in lieu thereof a new Section 215-15 reading as follows:

215-15. Penalties For Offenses. A. Whenever any owner, lessee, occupant or other person having charge or possession of improved or unimproved land shall violate the provisions of Section 215-12, 215-13 and/or Section 215-14, any

snow or ice placed or thrown by such person on or in the sidewalk or street may be caused to be removed by or on behalf of the Superintendent of Public Works. In that event, any duly authorized Code Officer of the Incorporated Village of Port Jefferson shall issue a violation to the Owner, lessee, occupant and/or other person having charge or possession of such land. All costs and expenses of the removal of the snow and/or ice by or on behalf of the Superintendent of Public Works shall be assessed against the owner, lessee, occupant or other person having charge or possession of the land and such expense shall, in addition, be assessed upon the land owned, occupied or possessed by the violator of this section and shall be made part of the annual tax levy on said land in the next ensuing fiscal year unless the amount is paid within fifteen (15) days after notice to such owner, lessee, occupant or other person. The cost and expense provided for herein shall be in addition to any penalty payable for any such violation.

B. In addition to the provisions of Article 215 above, each violation of Article 215 shall be punishable by a penalty of not more than \$250.00 or imprisonment for not more than fifteen (15) days, or both and a separate and distinct offense shall be deemed committed on each day during which a violation occurs or continues. In addition to such fine, the person against whom such fine is levied shall pay all costs and expenses incurred by the Incorporated Village of Port Jefferson in correcting such violation including, but not necessarily limited to, the cost and expense of removal of snow and ice.
