



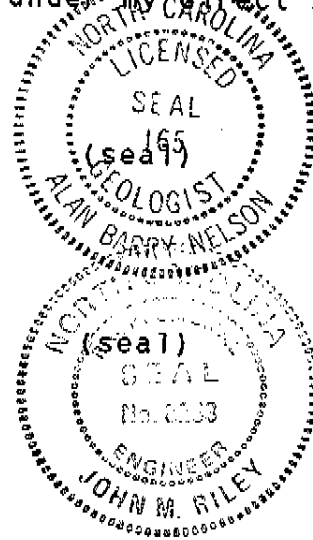

Dear Bill:

This is to notify you that the closure of the hazardous waste lagoon at the above referenced facility has been completed in accordance with their approved closure plan.

The total volume of material removed was 65,340 cubic feet of sludge. All material was landfarmed on the adjacent tract.

A clay cap was placed on the lagoon which conformed to 1.0×10^{-7} cm/sec permeability specifications as outlined in the closure plan. All disturbed areas were grassed and seeded.

A four foot high fence was placed around the entire perimeter of the site with warning signs posted every 50 feet.


Included are copies of the deed notice and notice to the local land authority as required.




