Assistance Requested: Detail of resource shortfalls, give specific deliverables or simply state the problem.

oil, and response to orphaned containers as necessary to mitigate actual and potential threats to public health and safety. Operations also to include recovery of Freon or other hazardous materials from white goods (refrigerators, freezers, stoves, ovens, washers, dryers, air conditioners), collection/disposal of e-waste and monitoring of immediate health and safety threats resulting from debris removal operations as requested in Ward County, and the municipalities within, as directed by FEMA. Firearms and ammunition will be collected by the Minot Police Department. EPA will coordinate environmental assessments and activities involving contaminated debris with USACE as appropriate. Actions may include support by any special teams requested by the FOSC, as well as special technical assets of all ESF #10 Support Agencies.

Total Cost of MA is estimated \$7,500,000

State Cost Share of MA is estimated \$1,875,000

MA will be funded incrementally with initial allocation of \$1,000,000

Based on:

$\$1,500/\text{home} \times 5,000 \text{ homes} = \$7,500,000$
