

<b>Description of Task:</b> <span style="float: right;"><b>Orphan Drum and Container Removal</b></span> An EPA team will deploy to Pottawattamie County Iowa between 09/19/11 and 09/30/11, which is included in the DR-1998-IA declaration for Public Assistance, Category A & B. The team will work with state, county, and local officials to locate and collect flood displaced hazardous materials drums and containers (orphaned containers) thru ground operations via foot, off-road type vehicles, automobiles, and watercraft based upon location, safe water conditions, and safe access to flood displaced drums. Drums will be recovered, staged and disposed of in accordance with the Resource Conservation and Recovery Act (RCRA). Based upon the safety recommendations of an EPA On-Scene Coordinator (OSC) all EPA personnel and contractors will conduct removal and potential categorization of orphaned containers in appropriate PPE in accordance with the CFR 1910.120. EPA will coordinate and obtain property access agreements with state and county agencies. EPA will keep a record with the number and approximate GIS location (based upon nearby waypoint locations) of containers located and removed. Further aerial surveys will be requested thru the FEMA and State of Iowa Joint Field Office. The EPA will provide a brief (1-5 page) written summary of container removal operations in Pottawattamie County and recommendations for any future container removal operations. The written summary should be submitted to the FEMA and Iowa Joint Field Office and the Iowa DNR no later than 5 days after operations conclude. All other conditions of the Mission Assignment remain in effect.
