

Description of Task: An EPA liaison will deploy to the Joint Field Office for the declared DR-1998-IA disaster to coordinate and direct the removal and disposal of flood displaced orphaned drums and containers that may contain hazardous materials with Federal, State of Iowa, County, and local officials. This mission assignment is funded under the Stafford Act the but the Emergency Support Function-10 planning portions of this mission will follow appropriate portions of the 40CFR, OSHA 1910.120 and the Resource Conservation and Recovery Act guidance to comply with appropriate environmental and safety guidance. The liaison should be in the JFO 1 to 2 days per week as requested by the Deputy State and Federal Coordinating Officers. The liaison will facilitate the EPA planning of orphaned container removal operations in all 6 of the DR-1998-IA disaster counties and coordinate the collection methods of containers in flood inundated areas, obtain property access agreements, identify collection points, staging areas, and identify potential environmental hazards for the DR-1998-IA unified command.
