As required by Paragraph 20 of the Administrative Order on Consent for Removal Action (Order) for the ESB, Inc. Site, three copies of this progress report for activities performed during September 2011 are submitted to the United States Environmental Protection Agency (EPA).

Although not required by the Order, this progress report includes those activities being performed at the request of the Georgia Department of Natural Resources, Environmental Protection Division (EPD) which have not been required by the EPA. These EPD-requested activities are indicated below in bold italics.

1. Response Actions Completed During September 2011 to Comply with the Order

- On September 12, 2011, Exide submitted to the EPA the progress report for the month of August 2011.
- ***On August 30 thru September 1, 2011, AMEC E&I, Inc. (AMEC) performed the regularly scheduled, quarterly round of groundwater sampling at the Site.***

2. Data Anticipated or Activities Scheduled for the Next Month

- ***AMEC will finalize the Groundwater Monitoring Report presenting the results of groundwater sampling performed on August 30 thru September 1, 2011.***

3. Problems Encountered in September 2011 or Anticipated

- No problems were encountered or anticipated in September 2011.

4. Actions Taken in August 2011 to Mitigate Anticipated or Actual Problems

- No actions were taken in September 2011 to mitigate anticipated or actual problems.

- *Analytical results of groundwater samples collected on August 30 thru September 1, 2011 were received. These results will be presented to the EPA in a Groundwater Monitoring Report to be submitted in October 2011. No other analytical data was received in September 2011.*

- No modifications to the Response Action or RAP were made in September 2011.
