#### Background

EPA is currently conducting a time-critical removal action at the Pennsylvania Mine Site. Additional removal activities may be required in the watershed.

#### Objectives

START will assess historical records/datasets and collect new data to help EPA determine if additional removal activities are warranted. The majority of the new data that is collected will be generated using XRF technology.

The Project Scoping Work Plan that is due 5 business days after the Start Date of this SOW (as documented in EAS) must include a cost estimate.

#### Tasks

	Task	Description
Yes	Project Scoping	START will schedule, attend and document a Project Scoping Meeting with the OSC. The objective of this meeting will be to discuss additional details related to the tasks and deliverables associated with this Statement of Work. This meeting may occur either in person or via conference call.
Yes	Site Reconnaissance	START will collect, manage and report photos, data and other information that can be used to describe conditions at a response or removal Site. START will document the specific data elements required to support this reconnaissance effort at the Project Scoping Meeting.
Yes	Sample Collection & Analysis	START will collect samples, arrange for their analysis and obtain appropriate analytical deliverables (such as data packages and electronic data deliverables).
Yes	Monitoring	START will establish and maintain real-time measurement equipment and networks. This task may include the use of EPA's Viper technology.
Yes	Assess Secondary Data	START will manage data and information obtained from secondary sources and provide recommendations to the OSC regarding its usability.
No	HazCating	START will categorize and report the hazards of unknown substances. START may also be required to perform compatibility tests in support of bulking operations.

No	Site Documentation	START will maintain a site specific log of response and/or removal activities performed by EPA, EPA contractors (START, ERRS, etc), PRPs and other parties (state, local agencies, etc). This record will include any relevant data, documents, photos and other electronic files).
No	PRP Oversight	START will support the OSC's efforts to assess and monitor the activities of PRPs at a site. This support shall include, but is not limited to: reviewing data and documents generated by the PRP, monitoring and documenting field activities, coordinating with PRP representatives and providing recommendations to the OSC.
