- Petroleum contaminated solids including but not limited to vegetative debris and absorbents will be placed into bags and transported in lined trailers to roll off boxes. Waste will be sent to Waste Management Pine Ridge Landfill under waste profile approval number **400393MS**.
- Loading bags into boxes will be an ongoing operation.
- Trucks will be transporting waste throughout the day and preloaded at the end of the day for landfill delivery at 7 am.
- Solid Waste / Household Garbage will be sent to Waste Management Pine Ridge for disposal.

**LIQUIDS:**

- Free product recovery will be achieved using vacuum trucks supplied by Clarko Oilfield Services.
- Recovered liquids will be sent to Clarko's disposal well. This is a permitted site by Mississippi OGB.
- If off site disposal/recycling is necessary, liquids will be sent to Liquid Environmental Solutions in Mobile, AL.
