STATEMENT OF WORK (SOW)

The Mississippi Department of Environmental Quality (MDEQ), at the request of the Federal OSC, will provide operational support to the Unified Command and the SCAT Team to respond to the oil spill associated with the New Augusta Train Derailment Spill event in Perry County. These activities are crucial in ensuring that Mississippi's watershed resources are protected and remediated if necessary. These staff will be providing the following functions:

- Provide Senior staff to participate in Unified Command Structure;
- Provide staff for Oil Spill Operations Oversight and Assessment teams operating in impacted area;
- Provide technical assistance to Unified Command's Planning Unit on environmentally sensitive areas, and help in identifying T&E flora and fauna;
- Provide staff to identify fish kills;
- Analyze the probable direction and time of travel of discharged materials
- Identify pathways to human and environmental exposure;
- Analyze the potential impact on human health, welfare, safety, and the environment posed by the discharge of oil;
- Analyze the potential impact on natural resources and property;
- Document all site specific costs incurred by the Recipient Agency for the response actions;
- Collect or review data such as site management practices, information from generators, photographs, historical photographic analyses, literature searches, and personal interviews for possible enforcement actions;
- Identify active or historical facility processes or operations that may have contributed to the discharge of oil;
- Observe and document state and private actions taken to conduct a response action;
- Prepare and submit all required accounting records in accordance with the National Pollution Fund Center (NPFC) Instruction 16451.2, "Technical Operating Procedures for

Resource Documentation under the Oil Pollution Act of 1990";

- Provide daily progress reports and/or consultations to EPA, as necessary;
- Review completeness of disposal documentation, such as manifests, waste profile data, and other information;
- Analyze Potentially Responsible Party (PRP) response documents and actions and recommend appropriate revisions;
- Analyze the accuracy, timeliness, and completeness of the PRP reports and associated actions;
- Document PRP activities and provide over-site;
- Identify concerned local and elected officials;
- Recommend cleanup and disposal options;

PERIOD OF PERFORMANCE

The period of performance begins January 31, 2014. This request covers the period of January 31, 2014, until the O&M phase ends. Operations and Assessment Team members and the Deputy SOSC will be used as needed during the monitoring and maintenance phase. Typically only 2-3 SCAT members will be on scene per day (up to 6 at the beginning), with the duration of the Monitoring Phase to be determined. The agreement can be extended upon agreement of both parties.

ESTIMATION OF COSTS

The estimated total costs for this statement of work for the stated period of performance for the spill response clean-up is approximately \$40,000, which is an estimate of all included costs of assigned personnel, travel, supplies, mileage and equipment expenditures required to accomplish the statement of work.
