Good afternoon Corey:

Attached for your review is a Revised Work Plan for Third Round of CAP 18 METM Injections document associated with the Michigan Plaza site. IDEM previously issued approval of an earlier version of this workplan in a letter dated August 22, 2011. Subsequent to the IDEM approval, MUNDELL oversaw completion of additional monitoring wells in late 2011. The results of the investigation have previously been provided in the report entitled Additional Investigation Activities Summary Report dated March 16, 2012. It is our understanding the report is currently being reviewed by IDEM.

MUNDELL, on behalf of AMMH, requests approval of a modified injection plan that takes into account the results of the aforementioned investigation. The plan has been expanded to provide some additional injection points in the three identified chemical Source Areas. If possible, we would appreciate an expedited review of the workplan so that at the very least, a verbal approval from IDEM to proceed is possible so that injection can be scheduled for the latter half of May.

Please note that the MUNDELL project manager for this site has changed recently. Ms. Sarah Webb has left MUNDELL for other consulting opportunities. Mr. Mark Breting will handle the day-to-day management of the site; I will continue to provide senior oversight on this project.

When you have a moment, can you let me know the status of the review of our previously submitted report?
