Description of Work: This TDD provides 200 hours to RST to conduct a site assessment at a former TB hospital, Old Saratoga Hospital, located in New Providence Township (Saratoga County) NY. The site was built in 1913 as a TB cure cottage, abandoned in 1960 and has remained a vacant, accessible building since then. It consists of a two story brick and concrete edifice occupying approximately 30 acres of otherwise vacant land. A fire occurred inside the building in 2014 which resulted in some interior destruction and partial floor collapse. The responding fire department indicated the presence of friable asbestos insulation and drums of chemicals. The site was referred to EPA for a removal action from the NYSDEC on May 20, 2015.

RST shall provide removal site assessment support and perform the following activities:

- 1) Provide four personnel with Level "C" PPE to support this removal assessment. Prior to mobilization contact the OSC to discuss site logistics. Field work will be 2 ~ 3 days. Date of mobilization to be determined.
- 2) Procure laboratory services for fifteen (15) asbestos grab samples for qualitative analysis using polarized light microscopy (PLM) and for VOAs, SVOAs, metals and reactives using standard test methods.
- 3) Mobilize to the Site with OSC.
- 4) Provide analytical results within 14 days of submission of samples to laboratory.
- 5) Document assessment in the form of dated and labeled photographs and a site logbook.
