SOLIDS:

- Petroleum contaminated solids including but not limited to vegetative debris and absorbents will be placed into appropriate containers and transported to roll off boxes. Waste will be sent to Nature's Way Energy Services, LLC, located in Fayette, MS under waste profile approval number (see attached).
- Loading bags into boxes will be an ongoing operation.
- Trucks will be transporting waste in roll-off boxes as needed. Trucks will not be staged offsite for early morning delivery.
- Solid Waste / Household Garbage will be sent to Nature's Way Energy Services, LLC, located in Fayette, MS for disposal.


