DESCRIPTION OF INCIDENT

THIS IS AN UPDATE TO A PREVIOUS NRC REPORT BASED ON VOLUME INCREASE

CALLER STATED THAT INITIALLY THE AMOUNT ESTIMATED DISCHARGE WAS 3 BARRELS OF CRUDE OIL, CURRENTLY THAT AMOUNT IS BELIEVED TO BE BETWEEN 40-70 BARRELS. CALLER STATED THERE OIL SATURATED SOIL AS FAR AS 100 FEET FROM THE WELL.

ORIGINAL NRC# 1145280

CALLER STATED THAT AN INDIVIDUAL HAD A FLOW LINE LEAK ON AN OIL WELL WHICH CAUSED A DISCHARGE 3 BARRELS OF CRUDE OIL ONTO THE GROUND WITH MOST OF IT GOING INTO THE ZED FORK CREEK.
