Initial Situation

A Union Pacific train derailed in Mosier, Oregon in Wasco County at 12:30 PDT on June 3, 2016. Initially, a total of eleven cars carrying crude oil were reported derailed, and sixteen were later confirmed. Four cars were reported on fire. Fire was put out by 02:05 PDT on June 4, 2016. The derailed cars are near the intersection of Rock Creek Rd and US Highway 30. Interstate 84 was initially closed immediately after the derailment, but both east and west bound lanes were opened by 22:45 PDT on June 3, 2016. A quarter mile radius was evacuated, including part of the town of Mosier, OR. Residents within a mile were advised as a precaution to be ready for evacuation as necessary. The Columbia River remains open to traffic as of this time.
