

CAMEO[®] Software Suite

Developed jointly by NOAA and EPA for more than 30 years



250,000 downloads and **1.2+ million visitors** to CAMEO Chemicals site each year

Keeping current: **~5 updates annually** to the CAMEO suite


Release Schedule

- **Spring 2020:**
 - CAMEO Chemicals 2.8
 - ALOHA 5.5
 - New CAMEO website
- **Beyond:**
 - Redesigned and renamed CAMEO*fm*
 - Mac OS improvements for 64-bit



Tier2 Submit 2019

- Completely redesigned
- Still imports last year's files
- Still adheres to the national Tier II data standard
- Still compatible with *CAMEOfm*
- Lots of new features and enhancements
- Rev3 coming soon—fixes bug and shows most recently imported records



Tier2 Submit State Customizations

Did you know you can request custom fields and rules in Tier2 Submit? You may be interested in collecting:

- State ID or facility ID numbers
- Which LEPC the facility reports to
- If this is a first-time submission or an annual submission
- Chemical carrier/transportation information
- Info you need to calculate submission fees (# of facilities, # of chemicals, etc. We can often auto-populate this for you.)
- Official-use-only fields, and more

Tier2 Submit State Customizations

Looking Ahead: CAMEOfm Redesign Beginning Soon

Who should this program be for?

- **LEPCs, data managers, and planners:** Help LEPCs comply with EPCRA and state requirements. Less focus on responder's needs and contexts.
- **Emergency responders:** Provide Tier II and other response-related information that can be viewed during drills and real emergencies, customized for the needs of hazmat teams, firefighters, etc.
