**ACTIVITIES COMPLETED TO DATE**

August 2 to August 22, 2007

- Completed the excavation of all building foundations. Re-excavated step footing at southeast building corner after discrepancy with approved submittal and foundation plan was resolved.
- Formed and poured all foundations and associated walls for new building. The steel reinforcement and anchor bolts were placed and tied per the plans and specifications.
- Completed the preparation of the subgrade of the building slab for installation of the underslab venting system.
- Completed the grading over Concrete Holder Pad 1 and Concrete Holder Pad 2. Excess Site soil was placed over the existing Concrete Holder Pad 2 to the maximum grading permitted by the design. Soil and crushed stone was placed over existing Concrete Holder Pad 1 to establish a uniform surface for the new concrete cap. Placed required base course material for new concrete caps.
- Completed installation of all RCP pipe and associated inlets.
- Stockpiled all concrete and C&D material for offsite disposal.
- Continued to maintain E&S measures, site security fencing, and boot/hand wash stations.

**ACTIVITIES PLANNED FOR AUGUST 22 – AUGUST 31, 2007**

- Complete installation of underslab venting system and pour building slab.
- Complete installation of the water and sanitary sewer services to new building.

- Complete excavation for turn-down sections and placement of steel reinforcement for new concrete caps. Place concrete for caps.
- Complete excavation and grading for acceleration/deceleration lane and prepare for site curb installation.
- Rough grade remainder of Site after completion of the installation of the water and sanitary sewer services to building.
- Dispose offsite all remaining vegetation and C&D material.

Penn E&R has agreed that a single rebar will be placed vertically through the pipe along its centerline to help prevent entry.
