



<b>5. GENERAL CONTROL OBJECTIVES FOR THE INCIDENT (INCLUDE ALTERNATIVES)</b> <ol style="list-style-type: none"> <li>1. Ensure safety of all responders and citizens in the area of the peanut bin.</li> <li>2. Safely monitor gas levels on and around the peanut bin, though out the operational period</li> <li>3. Safely load the dry ice in the bin by 1800 hrs.</li> <li>4. Save the structure of the bin along with as much as the product as safely possible.</li> <li>5. Secure perimeter around area by 0900 hrs</li> </ol>			
<b>6. WEATHER FORECAST FOR OPERATIONAL PERIOD</b> Winds North to North East at 5-10 mph. Temps form 80 degrees increasing to near 90 degrees with humidity levels ranging from 60% down to 40% in the afternoon.  Winds may shift Easterly in the afternoon.			
<b>7. GENERAL SAFETY MESSAGE</b> All responders on the dome shall wear proper PPE with SCBA, until readings are at a safe level. All fire fighters must have proper PPE on while at the dome area, according to your local protocol. All responders should continue to hydrate though out the operational period and use the buddy system to check each other's well being. All responders should monitor the wind shock for wind change.

Any person that is experiencing what is believe to be a medical emergency or has any major injury should be evaluated by the onsite Ambulance crew.								
If it is determined that the person requires transport and is not critical then an ambulance from station 5 will be called to transport if one is available to do so. If the patient is critical then the onsite ambulance crew will transport and a crew from Station 5 will be called to stand by until the onsite ambulance returns.								
In the event of a mass casualty incident mutual aid from surrounding volunteer squads as well as surrounding counties may be needed. Air medical services should also be utilized to transport any priority 1 and priority 2 patients.
