#### EXECUTIVE SUMMARY

A Mission Assignment for EPA to conduct household hazardous waste and orphan drum collection in New York as a result of Tropical Storm Lee was received. EPA has deployed resources to the Binghamton area, located in Broome County. OSCs are coordinating with local and state officials on activities to be conducted in the areas affected. Elsewhere in NY, collection of HHW and orphan containers continued in Delaware, Greene, Schoharie, and Essex Counties. EPA has received requests for assisting with recovery operations in Schenectady County.

New Jersey operations continued in Passaic County with the collection of orphan containers and HHW located in the Passaic River and surrounding municipalities. EPA continues to coordinate with local officials to determine an appropriate staging area in the County.

A state of vigilance will remain in effect for response personnel in the field and those working the REOC. As media finalize broadcasting events regarding the anniversary of September 11<sup>th</sup>, security measures in New York City remain high on alert.

• HHW was also removed from areas throughout Woodland Park, NJ.

• No HHW collection activities were conducted by EPA in Passaic County.

## Bergen County

 The REOC fielded calls relating to a sewer overflow in Hasbrouck Heights during Irene and Lee.

- Operations for HHW and orphan container recovery commenced in Sidney.
- Curbside collection of HHW and orphan recovery efforts continued in all three counties of the operational area.

  - <u>Hunter</u> Facility was operational.

Note: Numbers listed in the table are accurate at the time of delivery of this report. Field crews sometimes transfer numbers following the end of the reporting period due to communication issues. As a result, daily totals may change in future reports to capture all containers collected for that operational period. Because of this, operational period totals do not reflect true count numbers due to late reporting. However, the grand cumulative numbers are accurate at the time this report.

## TROPICAL STORM LEE (NY ONLY)

As a result of the remnants of TS Lee, 15 counties in New York State received a declaration of emergency. However, at the time of reporting a Mission Assignment has not been given to EPA from FEMA. Discussions at the IMAT indicate that Mission Assignments are being processed for the recovery of oil and hazardous substances to include household hazardous waste and orphan containers within the impact areas. A Federal Pollution Number has been obtained from the National Oil Pollution Funds Center to fund operations regarding oil recovery efforts should it become necessary.

# **NYSDEC Region 7 Area**

EPA deployed (2) representatives to the NYSDEC field office located in Kirkwood. EPA conducted the following operations:

- Coordinated with NYSDEC and other officials in the Broome and Tioga Counties.
- Initial reports indicated that Tioga County was devastated with debris scattered everywhere.
- Initial reports indicated that Johnson City and Conklin remain under water.

#### EPA Region 2 is currently manning the following coordination centers;

- NYSDEC Region 7 FO (Kirkwood, NY) (1) construction manager deployed to the NYSDEC Sub-Office to coordinate activities following the signature of a Mission Assignment.
- FEMA IMAT (Albany, NY) = (1) OSC coordinating with the State and FEMA on increases to existing Mission Assignments and processing of Mission Assignments for TS Lee NY.
- NJ State EOC (Trenton, NJ) (1) OSC coordinating and assisting with State "Requests for Assistance" (RFAs) and updating State elements on EPA Planning and Response Actions.
- EPA Region 2 REOC (Edison, NJ)
  - Coordinating efforts related to operations, planning, resources, and logistics from the REOC. The REOC is staging and coordinating the deployment of operational resources including EPA ERRS and RST contractor support.
  - The REOC is manning the Regional Hotline phone and addressing followup and response actions to incidents both related and unrelated to the impacts of Hurricane Irene.
  - The REOC is tracking situational information related to RFAs and changing conditions on the ground.

#### 2.2 Planning Section

The Region 2 Regional Emergency Operations Center (REOC) continued to manage EPA and contractor resources for support of field operations. Long-Term Staffing Plans have been generated to fill potential personnel needs in the REOC and in field operations.

#### 2.3 Logistics Section

A Daily Work Order was issued to the ERRS contractor for response personnel and resources to be deployed to the Binghamton, NY area for TS Lee (NY) operations.

# 2.5.1 Safety Officer

#### 7. Situational Reference Materials

Police were called to the Schoharie Debris Pile due to scavengers looking for copper.

All responders are asked to remain vigilant during the anniversary of the September 11<sup>th</sup> attacks.

Hotels in the Binghamton area are difficult to come by. Many people are displaced and several hotels have sustained damage.

Contact was made with EPA CEPD offices to ensure the safe conditions following the passing of TS Maria. No concerns were reported.

An Asbestos Handling Guide was generated for responders and contractors in the field at the HHW and orphan container recovery sites.

EPA responded to a spill at the Kinder Morgan Facility located in Staten Island. At approximately 07:45 this morning, the REOC was contacted by the National Response Center regarding a spill at the Kinder Morgan Facility located in Staten Island, NY. Approximately 60 bbls of #2 oil had been released into the secondary containment system. Material in the tank was being transferred to an empty tank. No release out of secondary containment occurred.
