Site Description

From approximately 1952 to 1977, the A.C. Lawrence Tannery (Tannery) facility, formerly located on the west bank of the Little Androscoggin River, used a metal trough to transport their waste to settling lagoons on the southeast bank of the Little Androscoggin River.

In the 1970's, the South Paris Publicly Owned Treatment Works was constructed and began accepting waste from the Tannery. In 1977, the lagoons ceased receiving wastes and a soil cap was placed over the sludge lagoons. The Tannery closed in 1985.

The land surrounding the Site is primarily wooded. A residential development is planned immediately south of the Site and currently the nearest residences are approximately 2000 feet northeast along Oxford Street. The land use on the west side of the river is industrial/commercial. The Site is located over a mapped sand and gravel aquifer.

This inactive seven acre Site is referred to as lot 7 on the Town of Paris, Maine Property Map R2. The cause of the contamination is from a non-oil manufacturing source (Tannery).

It is bounded:

- to the north by Little Androscoggin River;
- to the south by a residential development;
- to the east by Oxford Street; and,
- to the west by a railroad right-of-way and the Little Androscoggin River.

Current Activities

Week of May 21 2007

OSC McKeown, Site Lead (SL) Burton, Response Manager (RM) Lutsic, and one equipment operator mobilized. Activities for the week included load out of chromium-contaminated soil, backfilling and grading of Lagoons 1 and 3, and stockpile re-location. The crew de-mobilized for the Memorial Day weekend at the close of business May 24 2007.

MEDEP representative Wayne Paradis visited the Site and received an update from OSC McKeown.

U.S.ACE representatives Jon Kullberg and Mark Geib visited and met with OSC McKeown and RM Lutsic to discuss the riverbank repair plans.

2,089 tons of chromium-contaminated soil were shipped to the Juniper Ridge Landfill in Old Town (Alton), ME at a cost of \$87,173.

Week of 28 May 2007

OSC McKeown, EPA Chemist Clifford, SL Burton, RM Lutsic, one equipment operator, and one laborer mobilized. Activities for the week included the load out of chromium-contaminated soil, backfilling of Lagoons 1 and 3, and stockpile re-location. On 29 May 2007, Hertz delivered a water truck for dust suppression.

2,292 tons of chromium-contaminated soil were shipped to the Juniper Ridge Landfill in Old Town (Alton), ME at a cost of \$95,632.

Week of 4 June 2007

OSC McKeown, SL Lynch, RM Lutsic, 2 equipment operators, and one laborer mobilized to the Site. On 7 June 2007, START SL Burton mobilized. Activities for the week included load out of chromium-contaminated soil, dust suppression, and backfilling and grading of Lagoons 1, 2 and 3. On 8 June a conference call was held with Jon Kullberg of the US ACE to discuss the riverbank repair plan.

MEDEP representative Wayne Paradis visited the Site to discuss the map that they are producing using EPA-furnished GPS data collected on the 12 excavated lagoons.

2,798 tons of chromium-contaminated soil were shipped to the Juniper Ridge Landfill in Old Town (Alton), ME at cost of \$116,761.

Week of 11 June 2007

OSC McKeown, SL Burton, RM Lutsic, two equipment operators, and one laborer mobilized. Activities for the week included load out of chromium-contaminated soil, backfilling of Lagoons 1 and 3, and stockpile re-location.

Number of Samples Collected: 24 Under Pile Clearance (UPC) samples.

3,022 tons of chromium-contaminated soil were shipped to the Juniper Ridge Landfill, in Old Town (Alton), ME at a cost \$126,129.

On 11 June 2007, OSC McKeown issued a purchase request amendment to Shaw Environmental, Inc. (EPA Region 1 Emergency Rapid Response Services (ERRS) contractor) increasing the funding from \$3,282,000 to \$3,657,000. This included using \$100,000 of \$425,000 remaining in the contingency fund.

Week of 18 June 2007

SL Benoit, RM Lutsic, EPA Chemist Clifford, 2 equipment operators, and one laborer mobilized. SL Benoit provided coverage for START until 20 June 2007, SL Burton mobilized on 22 June 2007. Activities for the week included the load out of chromium-contaminated soil, continued grading along the southern wall of Lagoon 1, excavation along the berm of Lagoon 1, receipt and staging of large boulders for riverbank repair, sampling under areas where stockpiles had been located and subsequent on-site analysis.

MEDEP representative Wayne Paradis visited the Site and received an update from EPA Chemist Clifford.

1,658 tons of chromium-contaminated soil was shipped to the Juniper Ridge Landfill in Old Town (Alton), ME at a cost of \$69,167.

Week of 25 June 2007

OSC McKeown, RM Lutsic, 2 equipment operators, and one laborer mobilized. Activities for the week included the load out of chromium-contaminated soil, continued grading along the southern wall of Lagoon 1, excavation along the berm of Lagoon 1, and receipt and staging of large boulders for riverbank repair. RM Lutsic and John Kullberg USACE discuss options for riverbank repair.

MEDEP representative Wayne Paradis visited the Site to discuss the maps and receive an update from OSC McKeown.

1,170 tons of chromium-contaminated soil were shipped to the Juniper Ridge Landfill in Old Town (Alton), ME at a cost of \$48,824.

Planned Removal Actions

- * Dispose stockpiled chromium-contaminated soil;
- * Remove sheet piling along the Little Androscoggin River; and
- * Repair the response-related damage along the river bank.

Next Steps

- * Continue with T & D of chromium-contaminated soil.
- * Repair the response-related damage by rebuilding the bank.
